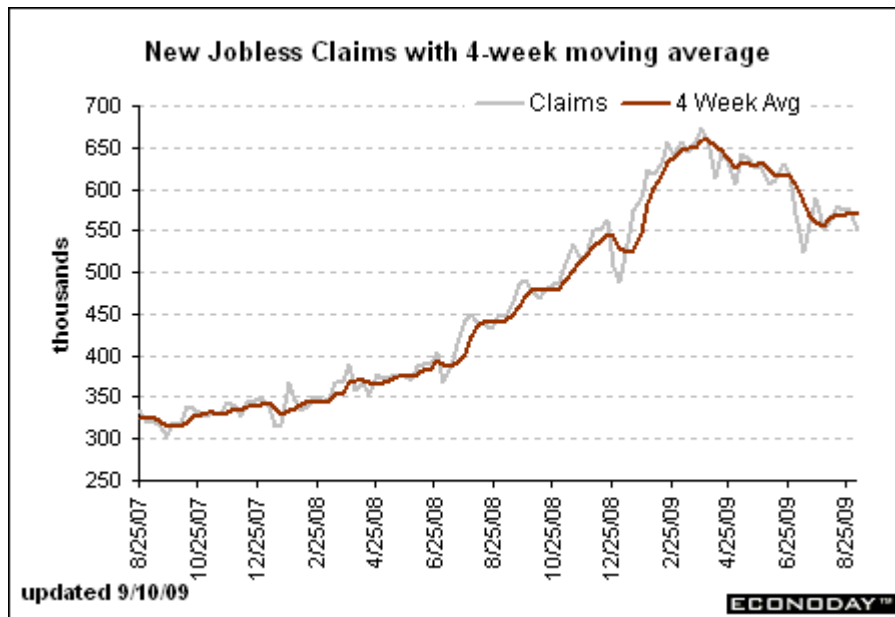


**New Jobless Claims Point to Positive Jobs Growth by 2010**
